IMPORTANT!! EPA PIPE IDENTIFICATION REQUIREMENT

The Environmental Protection Agency is requiring 100% of all households to report what type of water pipes are coming into their homes.

To assist in identifying what type of piping you may have, please review the photos:

Galvanized



Copper



Plastic



Also Plastic



PVC is another form of plastic but due to space limitations it is not pictured. There will be several ways to report the type of pipe in your home. **BE SURE TO INCLUDE YOUR NAME AND ADDRESS WHEN REPORTING:** The EPA requires that we report 100% of our homes.
