# REMINDER ON SERVICE LINE INVENTORY

In the winter 2022 newsletter we mentioned the IEPA (Illinois Environmental Protection Agency) requirement for all water districts to take an inventory of their service (water) lines going into homes. In addition to identifying where either lead or galvanized lines may be providing service to your home, there are additional questions regarding the piping and service in your home. This means someone from the Utility District will be contacting you with further questions. Please be patient as we complete this inventory requirement of the IEPA. This next step of information reporting must be completed by April 2024.

#### **GOING ON VACATION?**

Will you be out of town when your Utility bill is due? #### ATTEND A MEETING

### ServLine Insurance

This insurance was first offered to Lost Lake in October 2017. This is an Opt-Out coverage meaning everyone was enrolled at that time unless they chose to opt-out. If you opted out and now wish to enroll, call ServLine at 815-718-6663 to do so. There is a 30-day waiting period for anyone re-enrolling at this time. ServLine offers water and sewer line insurance. Homeowners are responsible for the laterals that come from the water main on the street. This insurance is a no deductible plan that will cover the replacement of those lines. #### **NEW SAND FILTER DOING ITS JOB**

Last fall the LLUD completed the replacement of sand filter #1 which had reached the end of its useful life. We are happy to report that after months of testing it is working well and shows it is doing the job of processing the final steps of effluent (sewage) filtering as it should. A lot of work went into the process of removing the original aggregate (layers of rock and sand) and the underlying piping and ground barrier in order to replace it in its entirety. It is always gratifying when all the hard work pays off, even if it is dealing with sewage!!
